We are seeking artists who wish to exhibit and sell their products at a local event. Alden Lane Nursery has been hosting Art Under the Oaks each July for more than 30 years. The event attracts approximately 3,000 people from Livermore, Pleasanton and beyond. The 2-day event (which is FREE for attendees) includes art vendors, food, music, and activities for the whole family.

Art Under the Oaks features handmade and locally made products. To provide a more interesting experience for our customers, we will regulate the number of artists in any product category. Space is limited. Exhibitors have the option to pay for a single day (\$175) or the 2-day length of event (\$275).

When submitting the application, we would like to see at least 4 photos of products you plan to sell at our event. ***We would also like at least 1 photo of a prior booth set up.*** These can be included with the application or e-mailed to pamj@aldenlane.com. Artists must provide their own booth, accounting for all weather conditions (including the need for shade). Height must not exceed 9' without prior permission.

You must hold a valid tax resale number to participate in Art Under the Oaks. A copy of your permit must be submitted after your participation is accepted.

We would love to feature artists demonstrating their craft. This makes it much more interesting for the customer and can assist with drawing people to your booth.

There are specific parking rules set up by Alden Lane Nursery for this event. These rules have been made to consider the needs of artists, customers, visitors, the neighborhood and nursery personnel.

ARTIST BENEFITS

RULES These rules and regulations governing the exhibits are part of the agreement for space.	STAFFING & SECURITY Exhibit must be always staffed by Artist or their designee. You are responsible for the security of your own product. You must remove all merchandise at the end of each day. You may leave booth structure and display items.
USE OF SPACE Artists shall arrange their exhibits, so they do not obstruct other exhibits or walkways. All exhibits must fit within the assigned space. Arrangement of merchandise in the booth must be attractive, neat and orderly. Vendor must protect the facility and property from damage. Nothing may be tacked, nailed, taped, glued or in any way attached to facility property or trees.	CANCELLATIONS In the event a vendor becomes unable to attend the event, refunds will be made as follows: for cancellations prior to May 15, 50% refund; after May 15, no refund. All cancellations must be in writing. Postmarks will be used to determine eligibility. Any unoccupied space will be forfeited by the vendor without a refund.
BOOTH SET UP Unloading and set up of booth must be completed within the time specified prior to opening each day. Unloading can be done in designated loading zone areas, then vehicles must be moved to specified parking lot. Participants must provide loading and unloading equipment and labor.	PRODUCT QUALITY All items sold in booth must be handmade or original art produced by the artist on this application. All artwork exhibited in the booth must be in the same category and be of the same quality and style as the work selected by the jury.
PARKING Artists will be required to submit make and license numbers of their vehicles (and their booth helpers' vehicles). These are the only cars that will be allowed to unload or pick up. Cars must then be moved to specified artist parking lot and a shuttle taken to/from the Nursery.	PROHIBITED ITEMS The following items are prohibited - music, flammable materials, alcohol & tobacco. There should be no children or animals in the booths without prior permission. Keeping in mind that this is a family-friendly event, we reserve the right to prohibit any display or product which the Management does not judge suitable.
LIABILITY Alden Lane Nursery and their agents shall not be liable to a vendor (or their agent) for any damage to or for the loss or destruction of an exhibit or the property of a vendor (or their agent) or injuries resulting from any cause.	ISSUES NOT COVERED HEREIN Nursery Management shall rule upon matters or issues not covered herein. Their determinations on issues, problems or questions that arise shall be binding.
